Dear Chairman Scott and Ranking Member Foxx:

On behalf of the nation's community college chief executive officers and trustees, we write to state our strong support for FY 2022 budget reconciliation legislation that will be marked up today by the Education and Labor Committee. The legislation would dramatically increase the ability of students to attend and succeed at community colleges, as well as the ability of these institutions to continue to provide high-quality programs and needed student supports. It would lead to millions more Americans being able to generate family-sustaining wages.

Community colleges and students across the country applaud this historic investment in community colleges and higher education broadly. It is particularly timely as the nation struggles to emerge from the economic dislocation caused by the ongoing pandemic. Items that are of greatest importance to community colleges include:

- **America's College Promise:** This new federal-state partnership to eliminate tuition and fees for most community college students is a bold step that can make postsecondary education truly universal in America. We appreciate the committee's recognition of the different state structures and funding arrangements and are eager to work with colleges and states to attain widespread program participation.
- **Pell Grant maximum:** The \$500 increase in the Pell Grant maximum will greatly increase community college affordability. Coupled with what we hope will be at least a \$400 increase in the maximum grant through the FY 2022 appropriations process, it would represent the single largest one-year increase ever in the grant.
- **Federal support for dreamers:** The legislation makes DACA students eligible for Title IV. This is a longstanding priority for colleges across the country, helping hundreds of thousands of people to attain the American dream.
- **Student Success Grants:** This state-based grant program will lead to enhanced outcomes at community colleges. The legislation's focus on evidence-based approaches reflects growing consensus about what works best in helping students succeed. However, these interventions are costly, which makes the legislation so helpful.



- Community College Workforce Partnerships: This \$2 billion program responds to the growing awareness of the longstanding skills gap in this country, and the benefits of augmenting community colleges' workforce roles. The program's design reflects previous successful federal workforce programs.
- Carl Perkins Act and Adult Education Acts: The legislation provides additional needed support to some of the most underfunded programs in the Department of Education. Funding will help individuals beginning on career pathways as well as those in mid-career. It will also help community colleges provide basic English and math literacy to individuals who need it for additional training and skilling.

The reconciliation provisions being brought before the Education and Labor Committee will have a tremendously positive overall effect on students, institutions, and our economy and society. We urge passage of this legislation and look forward to working with you to secure its enactment.
