# Digital Equity Education Roundtables (DEER) Initiative: Updates and Findings



## Digital Equity Education Roundtables (DEER) tech.ed.gov/DEER



The DEER Initiative aims to identify barriers that learner communities face in adopting reliable, high-speed internet and technology tools for learning, recommend strategies that leaders can leverage to navigate these barriers, amplify examples of solutions, and spur community action and commitment to close the digital divide.

#### What did we do?

Host a series of national conversations with organizations championing educational and digital access to identify adoption barriers faced by learner communities furthest from digital opportunities and promising, impactful solutions.

**Publish a resource for leaders** to inform states' digital equity plans regarding equitable broadband adoption strategies.

**Spur community action and commitment** aligned with the recommendations made in the published guidance resource.

# What did we find? Availability Barriers & Strategies

#### **Availability Barriers**

- Lack of reliable, high-speed broadband
- Lack of adequate device access from home
- Digital redlining
- Building-level barriers

#### **Availability Strategies**

- Hotspot and device distribution
- Leveraging public spaces
- ISP partnerships

# What did we find? Affordability Barriers & Strategies

## Affordability Barriers

- High cost of broadband and technology tools for learning
- Lack of sustained funding for programs and resources

## **Affordability Strategies**

- Subsidized access
- ISP partnerships
- Sustained funding efforts

## What did we find? Adoption Barriers

- Exclusion of impacted communities
- Distrust of systems and programs
- Lack of intentional collaboration
- Lack of disaggregated data
- Lack of inclusive communication
- Lack of access to critical support resources

## What did we find? Adoption Strategies

- Co-creating solutions
- Technical support efforts
- Building digital literacy skills
   & digital resilience
- Leveraging trusted community assets


